Power 105-1's "Tony! Toni! Tone!" Contest Official Rules

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. At or around 11:00am CT, 1:00pm CT, and 2:00pm CT each weekday (each, a "Selection Day"), when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 913-933-1051. Caller number ten (10) to the Station, as determined by the Station in its sole discretion, will give their answer for the trivia question. If that caller answers correctly, they are the winner of the Prize for that Selection Day after providing the station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If that caller answers incorrectly, subsequent callers will be taken until answered correctly All entries may be played on the air. Time Delay Between Over-the-Air Analog Signal and Internet **Broadcast:** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
